REPORT OF THE CREDENTIALS COMMITTEE TO THE CONFERENCE

(presented by the Chairman of the Credentials Committee)

- 1. At its first meeting, held on 5 October 2009, the Conference established a Credentials Committee, and decided that it would have the same Chairman and the same composition as during the first session of the Diplomatic Conference. H.E. Mr Mohammed Kawu IBRAHIM of the Nigerian delegation was Chairman of the Committee, which comprised Argentina, Australia, Greece, Indonesia and Nigeria, while the Swiss Federal Department of Foreign Affairs provided its services as advisor.
- 2. The Credentials Committee held a first meeting on 5 October 2009, with members as follows:

- 3. At the plenary meeting of the Conference held on 6 October 2009, the Chairman of the Credentials Committee presented a preliminary Report, informing the Conference that as of 5.30 p.m. of that day, 49 States, one regional economic integration Organisation and 12 International Organisations and groups had registered for the Conference. Credentials in due and proper form had been submitted by 31 States and nine International Organisations and groups. Full powers to sign the international legal instrument to be adopted by the Conference had been presented by four States.
- 4. The Committee recommended to the Conference that, in conformity with Rule 4 of the Rules of Procedure, all delegations registered be permitted to participate in the Conference pending receipt of their credentials in due and proper form; the Conference accepted this recommendation. The Committee nevertheless urged those delegations that did not submit their credentials to do so as soon as possible.

- 5. The Credentials Committee held its second meeting on 8 October 2009. At this meeting, for technical reasons the Republic of Korea stood in for Indonesia (Mr PARK Whon-II attended the meeting). The Credentials Committee found that one State and two International Organisations had registered for the Conference since its previous meeting. The Committee found that Credentials in due and proper form had been submitted by 13 additional States, and five additional International Organisations and groups. Six States had been accepted as observers. Full powers to sign the international legal instrument to be adopted by the Conference had been presented by two additional States.
- 6. At its second meeting, the Credentials Committee found that, in total, 50 States, one regional economic integration Organisation and 13 Organisations had registered for the Conference. The credentials of the delegations of the following 44 States were found to be in due and proper form:

- 7. The credentials of the delegation of one regional economic integration Organisation were found to be in due and proper form, *i.e.* the European Community. The credentials of the European Central Bank (ECB) were found to be in due and proper form.
