#### UNIDROIT RESEARCH SCHOLARSHIP PROGRAMME

Implementation Report for 2018 \*



#### I - Background

The Unidroit Research Scholarship Programme bridges two concerns that are closely connected to the core activity of Unidroit: 1 - furthering the general objectives of Unidroit, *i.e.* harmonising and modernising private law, with a particular attention to developing countries and countries in economic transition; and 2 - promoting legal research in a Library which is renowned for its holdings relating to private international law and located at the seat of a pioneering organisation in the field of private law harmonisation.

The Programme was launched in 1993 and, since its beginning, has hosted 380 researchers (civil servants, academics, judges and practitioners) from 64 countries. In addition to the advantages for the beneficiaries and the legal community in their countries of origin, the Programme also has important institutional effects, in that it opens doors for UNIDROIT to new contacts, often at the highest level, both in its member States and in non-member States. This improves the exchange of information between the Institute and the legal community in these countries and increases UNIDROIT's opportunities to publicise its activities.

The scholarship programme provides beneficiaries with the opportunity to carry out research in the library. Assistance is provided by UNIDROIT staff in the form of logistic support, bibliographical guidance and, depending on the particular research project, the organisation of exchange meetings with staff members. In addition, whenever possible, researchers have the opportunity to attend the meetings organised at UNIDROIT as guests. However, UNIDROIT does not provide academic supervision as such. A certificate is issued at the end of the research period.

### II - Financial resources for the Programme in 2018

According to the General Assembly's decision at its 2012 session, the Scholarship Programme has relied entirely on voluntary contributions since 2014.

The sources of funding of the Programme in 2017 are as follows:

- ❖ The Scholarship general fund (carry over from 2017 and grant from Members of the Governing Council on a personal basis)
- ❖ Transnational Law & Business University (TLBU) (carry over from 2017)
- The Unidensity Foundation (carry over from 2017 and grant received in 2018)
- ❖ The Ministry of Commerce of the People's Republic of China (carry over from 2017 and grant received in 2018)

A table reporting the amounts received and how they have been spent can be found in Annex I. Annex II notes the Treasurer's Conclusions, which certify the financial report of the Scholarship Programme in 2018.

#### III - Objectives and selection procedure

The Programme is publicised on the Unidroit Internet webpage, and by the Secretariat also among member and non-member States, Governing Council members and correspondents, as well as academic institutions in targeted countries. Academic institutions that have a cooperation agreement with Unidroit are welcome to present candidates. Beneficiaries are selected under the guidance of the Secretary-General based upon any requirements set by donors, and according to the main following criteria/considerations:

- (a) the subject matter and the presentation of the research project, in particular its connection with UNIDROIT past or present activities (subjects on the current Work Programme, or adopted instruments, and in general dealing with private law in the broadest sense);
- (b) the potential application of the undertaken research in promoting legislation, academic dissemination, judicial application;
- (c) the profile of the candidate based on his/her academic and professional qualifications, the references provided to take best advantage of the scholarship opportunity
- (d) additional considerations include the objective of achieving the widest possible geographical distribution as far as the beneficiaries' countries of origin are concerned (bearing in mind the aim of hosting scholars both from member States to enhance their participation in the Institute's activity and from non-member States to build networks to disseminate UNIDROIT'S work)

Funding received from donors is exclusively allocated to scholars to support local expenses in Rome (accommodation and local expenses). Other expenses related to the management of the programme (staff and library documentary resources) rely upon the UNIDROIT general budget. Candidates admitted as invited scholars receive either a full scholarship or – most often - a partial scholarship when – as they are encouraged to do so - they can rely on personal funding or complementary sponsorship from their institution of origin, or other third party donor. The Secretariat devotes particular attention to ensuring that financial resources are used as efficiently as possible.

Although candidates are welcome to apply on an individual basis, cooperation agreements are in place for joint scholarships with a number of academic institutions. Cooperation agreements generally provide for a competitive selection procedure within the partner institution, and may imply shared expenses or full coverage by the partner institution.

Cooperation agreements have been implemented with: Universidad Argentina de la Empresa (UADE) (Argentina); Universidad de los Andes, Universidad de Talca and Pontificia Universidad Católica de Valparaíso (Chile); University of International Business and Economics, Beijing and Zhongnan University of Economics and Law (ZUEL), Wuhan (PR China); Universidad Externado (Colombia); Cairo University Faculty of Law and the Egyptian State Council (Egypt); Islamic Azad University – Science and Research Branch, Tehran (Iran); TLBU Graduate School of Law (Republic of Korea); Nagoya University (Japan); Babes Bolyai University (Romania); University of Johannesburg (South Africa); University of Oxford - Faculty of Law - Commercial Law Centre at Harris Manchester College (United Kingdom); Loyola University Chicago (USA/Italy),

In 2018, the Programme hosted 10 scholars from 7 countries (see the list in Annex III).

The beneficiaries' summary research reports in 2018 are available in a related document available in electronic format only and accessible through this <u>link</u>. Although very diverse, the Secretariat believes that they bear witness to the benefits deriving from the research opportunity. One ought to bear in mind that these reports are of a descriptive, non-scientific nature, and that the academic results are in the form of articles, theses, books, teaching material etc. In most cases, the candidates have helped forge or strengthen co-operation networks with universities and research centres, and generally contribute to the promotion of UNIDROIT instruments worldwide.

#### IV - Perspectives

The Secretariat recalls that this Programme has proven to be an efficient means of underpinning the Organisation's harmonisation work and should be seen as forming an integral part of the Institute's mission.

The Secretariat expresses its gratitude to all donors in 2018 and hope that they will wish to renew their financial commitment, and that new donors may join them, so as to maintain the scheme's financial potential and enable a satisfactory number of candidates to be presented and accepted into the Programme.
