INTRODUCTION

1. The *Convention on International Interests in Mobile Equipment* (the Convention) and the Protocol thereto on Matters specific to Aircraft Equipment (the Aircraft Protocol) were opened to signature in Cape Town on 16 November 2001. The *Luxembourg Protocol to the Convention on International Interests in Mobile Equipment on Matters specific to Railway Rolling Stock* (the Luxembourg Protocol) was opened to signature in Luxembourg on 23 February 2007. UNIDROIT is designated the Depositary to each of these instruments, and this memorandum provides an update on the implementation of the Institute's depositary functions under them.

STATUS

CONVENTION / AIRCRAFT PROTOCOL

2. The Convention (as applied to aircraft objects) and Aircraft Protocol entered into force on 1 March 2006 following the deposit of the eighth instrument of ratification/accession.

3. Since the preparation of the memorandum for the 86th session of the Governing Council, instruments of ratification/accession in relation to the Convention and the Aircraft Protocol have been lodged by the following States: Albania, Cape Verde, India, Indonesia, Mexico and the Syrian Arab Republic (Convention only). In addition, the provisions of the Convention and Aircraft Protocol relating to withdrawal of declarations and the making of subsequent declarations were utilised by Kenya (replacing its declaration under Convention Article 39(1)(a)) and Nigeria (replacing its declaration under Convention, the Aircraft Protocol and the Luxembourg Protocol as at 31 March 2008.

CONVENTION / LUXEMBOURG PROTOCOL

4. There have been no ratifications/accessions in relation to the Luxembourg Protocol. It will enter into force following the 4th ratification/accession.

OTHER DEVELOPMENTS

5. The Secretariat understands that political issues that had delayed the European Commission's decision whether to accede to the Convention and its protocols have now been resolved.

ACTIVITIES

General

6. UNIDROIT'S responsibilities as Depositary under the Convention, the Aircraft Protocol and the Luxembourg Protocol are specified in each instrument, and include the operation of a system for the receipt and notification of all instruments of ratification, declarations and other documents lodged with the Depositary. The UNIDROIT Secretariat is continuing to liaise closely with a number of States that are at various stages of the ratification/accession process. The Cape Town update email notification service which was launched in 2007 is approaching 300 subscriptions.

CONVENTION / AIRCRAFT PROTOCOL

7. The UNIDROIT Secretariat has maintained close working relationships with the International Registry (Aircraft) and the Supervisory Authority (the International Civil Aviation Organization), including ongoing discussions on issues arising out of the International Registry Regulations. Unfortunately, the Supervisory Authority has not yet provided its report under Article 61 of the

Convention, which is required to enable the completion of the first yearly report pursuant to Article 61(1) of the Convention and Article XXXIV of the Aircraft Protocol. The Supervisory Authority report is now expected to be made available by the end of May.

CONVENTION / LUXEMBOURG PROTOCOL

8. Resolution No. 1 of the Luxembourg Diplomatic Conference established a Preparatory Commission to act, pending the entry into force of the Protocol, as Provisional Supervisory Authority. The tasks of the Preparatory Commission include the establishment of the International Registry. The first session of the Preparatory Commission, hosted by OTIF, was held in Berne on 16 and 17 July 2007, and decided the process for the establishment of the International Registry, including the details of a competitive bidding process for the selection of the Registrar to operate the International Registry for Railway Rolling Stock. The second session of the Preparatory Commission will be hosted by UNIDROIT in Rome from 8 to 10 April 2008. The agenda for the session includes the selection of the Registrar to operate the International Registry. The UNIDROIT Secretariat's very productive working relationship with the OTIF Secretariat is expected to continue over the coming months as the International Registry for Railway Rolling Stock is set up.

PUBLICATIONS

The Official Commentary to the Cape Town Convention and Aircraft Protocol, by Professor 9. Sir Roy Goode, was published by Unidroit in 2002 pursuant to Resolution No. 5 of the Cape Town Convention. Since its publication, 800 copies have been sold, and the Official Commentary has become the definitive reference source on the Convention and Aircraft Protocol. However, the Official Commentary does not take into account a number of significant developments that have occurred since its publication, including the entry into force of the Convention and Aircraft Protocol, the establishment of the International Registry and regulations underpinning its operations, and extensive practical experience in relation to declarations and commercial transactions under the Convention. Further, Resolution No. 4 of the Luxembourg Diplomatic Conference resolved to request that the Rapporteur (Sir Roy Goode) prepare an official commentary on the Luxembourg Protocol in cooperation with OTIF and UNIDROIT and the chairmen of the Conference's committees. In light of these developments, Sir Roy Goode has prepared a revised edition of the Official Commentary (Convention + Aircraft Protocol) and a new Official Commentary (Convention + Luxembourg Protocol). Comments on the official commentaries have been sought from the negotiating States and participating observers to each of the diplomatic conferences. The UNIDROIT Secretariat is currently assisting in the revision and editing of these official commentaries, which are expected to be published in May 2008 (complimentary copies will be distributed to Governing Council members and negotiating States). The Council is asked to approve the publication and distribution of the Revised Edition of the Official Commentary to the Cape Town Convention and Aircraft Protocol and of the Official Commentary to the Cape Town Convention and Luxembourg Protocol

PROMOTION AND PUBLICITY

10. The UNIDROIT Secretariat has continued to promote the Convention, the Aircraft Protocol and the Luxembourg Protocol wherever possible, as set out at page 12 of the Annual Report for 2007. The Aviation Working Group (led by UNIDROIT Correspondent Mr Jeffrey Wool), the Rail Working Group and the UK Foundation for International Uniform Law have also continued to promote implementation of the Convention and its protocols.

ACTION TO BE TAKEN

11. The UNIDROIT Secretariat would invite the Governing Council to approve the distribution of the Revised Edition of the Official Commentary to the Cape Town Convention and Aircraft Protocol and of the Official Commentary to the Cape Town Convention and Luxembourg Protocol.
