UNIDROIT SCHOLARSHIP AND INTERNSHIP PROGRAMME

Implementation Report for 2019 *



I - Background

- 1. The Unidroit Scholarship and Internship Programme supports Unidroit's core objective of harmonising and modernising private law by facilitating legal research in the Unidroit Library, renowned for its private international law collection.
- 2. The Programme was launched in 1993 and, since its inception, has hosted more than 400 researchers (civil servants, academics, judges and practitioners) from 65 countries. In addition to the advantages for the beneficiaries and the legal community in their countries of origin, the Programme also has important institutional effects, by introducing new contacts to the Institute who then support Unidroit's work in both member States and in non-member States. This improves the exchange of information between the Institute and the legal community in these countries and increases Unidroit's opportunities to publicise its activities.
- 3. The scholarship programme provides beneficiaries with the opportunity to carry out research in the library. Assistance is provided by UNIDROIT staff in the form of logistic support, bibliographical guidance and, depending on the particular research project, discussions with staff members and presentations of their research topic to the Institute. In addition, whenever possible, researchers have the opportunity to attend the meetings organised at UNIDROIT as guests. However, UNIDROIT does not provide academic supervision as such. A certificate is issued at the end of the research period.
- 4. The internship programme allows a select number of interns to participate in the work of the Secretariat. Internship activities relate to subjects on the Institute's current Work Programme, and to Unidroit instruments that have already been adopted, in particular as regards their

implementation and promotion. Interns conduct research on specific aspects of their assigned subject and to prepare concept notes, draft documents and reports of meetings, prepare translations, and generally assist the professional staff of the Secretariat. Interns are directly supervised by UNIDROIT officers during their internships.

II - Objectives and selection procedure

- 5. The Programme is publicised on the Institute's website and promoted by the Secretariat to member and non-member States, Governing Council members and correspondents, as well as academic institutions. Academic institutions that have a cooperation agreement with Unidroit are welcome to present candidates. Beneficiaries are selected under the guidance of the Secretary-General according to the following criteria and any additional requirements set by donors:
 - (a) the subject matter and quality of the proposed research project and its connection with UNIDROIT'S past or present activities (topics on the current Work Programme, adopted instruments, or dealing with international private and commercial law generally).
 - (b) the potential application of the research in promoting legislation, academic dissemination, judicial application.
 - (c) the profile of the candidate based on academic and professional qualifications and references.
 - (d) additional considerations, including achieving the widest possible geographical distribution of scholars and interns (the Programme hosts scholars both from member States to enhance their participation in the Institute's activity and from non-member States to build networks to disseminate UNIDROIT's work).
- 6. Funding received from donors is exclusively allocated to scholars and interns to support their expenses in Rome (accommodation and local expenses). Other expenses related to the management of the programme (staff and library documentary resources) rely upon the UNIDROIT general budget. Scholars receive either a full scholarship or a partial scholarship and are able to rely on personal funding or complementary sponsorship from their institution of origin, or other third-party donors. The Secretariat devotes particular attention to ensuring that financial resources are used as efficiently as possible.
- 7. Although candidates are welcome to apply on an individual basis, cooperation agreements are in place for joint scholarships with a number of academic institutions. Cooperation agreements generally provide for a competitive selection procedure within the partner institution, and may imply shared expenses or full coverage by the partner institution.
- 8. Cooperation agreements have been implemented with: Universidad Argentina de la Empresa (UADE) (Argentina); Universidad de los Andes, Universidad de Talca and Pontificia Universidad Católica de Valparaíso (Chile); University of International Business and Economics, Beijing and Zhongnan University of Economics and Law (ZUEL), Wuhan (PR China); Universidad Externado (Colombia); Cairo University Faculty of Law and the Egyptian State Council (Egypt); Islamic Azad University Science and Research Branch, Tehran (Iran); TLBU Graduate School of Law (Republic of Korea); Nagoya University (Japan); Babes Bolyai University (Romania); University of Johannesburg (South Africa); University of Oxford Faculty of Law Commercial Law Centre at Harris Manchester College (United Kingdom); Loyola University Chicago Rome Center (USA/Italy).

III - The Programme in 2019

9. Since 2014, the Scholarship and Internship Programme has been entirely funded by voluntary contributions. The Programme relies on the benevolence and generosity of its sponsors, which include

the Ministry of Commerce of the People's Republic of China, the UNIDROIT Foundation and the Transnational Law and Business University (TLBU).

- 10. The long-term goal of the Scholarship and Internship Programme is to be able to provide funding to all applicants accepted into the Programme. However, due to limitations in funding, currently only a select few applicants receive research scholarships or internship stipends.
- 11. In 2019, the Programme provided funding to ten scholars and two interns from eight countries. Annex I provides a financial summary of the Programme's operation in 2019. Annex II provides some details regarding each funded scholar/intern and their research topics.

IV - Conclusion

- 12. The Scholarship and Internship Programme has proven to be an efficient means of underpinning the Organisation's core work and forms an integral part of the Institute's mission.
- 13. The Secretariat expresses its gratitude to all donors in 2019 and hopes that they will renew their financial commitment, and that new donors may join them, so as to maintain the scheme's financial potential and enable a satisfactory number of candidates to be presented and accepted into the Programme.
