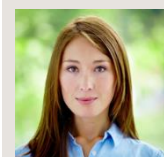

Background information about the ELI & UNIDROIT project

The project “From Transnational Principles to European Rules of Civil Procedure” has been undertaken in cooperation between the European Law Institute (ELI) and the International Institute for the Unification of Private Law (UNIDROIT) since February 2014.

The divergences between current national rules on civil procedure developed over a long period of time and the question of which rules are applicable in a situation when parties enter into a transaction involving more than one State, led to the conclusion that a certain degree of unification of the rules governing private international law would unequivocally contribute to the simplification of the resolution of civil disputes across Europe. Therefore, the ELI and UNIDROIT undertook a joint venture aimed at the analysis of different aspects of civil procedure rules and producing a draft set of unified regional rules. Greater harmony and homogeneity of such important legislation within Europe would also facilitate the free movement of citizens and businesses across borders.

Aim of the conference

As the work on the structure of the rules nears completion, this public conference aims at presenting the advanced results achieved by the project’s current and former working groups. Participants of the conference will have a chance to get a sense of the whole project as the work is drawing to an end with an estimated date in spring 2019. The members of the project as well as other esteemed experts in the field of civil procedure will present the achievements and challenges of the work of the respective working groups and stimulate a discussion on selected pressing legal issues in the area of civil procedure.
