In this period of economic recovery following the global pandemic, businesses in different countries around the world increasingly face challenges in obtaining finance for major projects that would support sustainable economic development. These challenges are particularly acute in the mining, agriculture and construction (MAC) and rail sectors. One major constraint on access to credit in these critical sectors is a lack of clear, balanced and harmonised legal rules.

The MAC and Rail Protocols to the Cape Town Convention provide a solution to these problems. As international treaties developed by the International Institute for the Unification of Private Law (UNIDROIT), the MAC and Rail Protocols create an international legal framework that will fuel sustainable development, improve access to credit, and enable businesses to access modern machinery.

Hosted by the University of Cambridge and UNIDROIT, this international conference will provide an opportunity for participants to learn about the operation of the MAC and Rail Protocols and how they facilitate credit expansion and sustainable development. The conference will also consider regional perspectives from Africa, Asia and Latin America, and what countries can do to realise the benefits of the MAC and Rail Protocols.

Diplomatic representatives, government officials, private sector stakeholders, legal practitioners and academic experts are warmly invited to attend the conference. The Conference will be conducted in English. Attendance is free, and online participation is possible. Coffee, tea and a light lunch will be provided for participants.
